**A BY-LAW TO AMEND ASSESSMENT SCHEDULE DUE TO CHANGES IN  
OWNERSHIP AND SUBDIVIDED LANDS IN THE TOWNSHIP OF AUGUSTA FOR THE  
TANNEY MUNICIPAL DRAIN**

---

**WHEREAS** By-law Number 1483, enacted the 20<sup>th</sup> day of April, 1971, provided for the maintenance of the Tanney Municipal Drain based on the Engineering report dated the 30<sup>th</sup> day of September, 1970, as submitted by R.M. Kostuch and C.G. Hanes of R.M. Kostuch Associates Ltd.

**AND WHEREAS** the Assessment Schedule requires updating due to changes in property ownership and the subdivision and severances of lands within the Drain.

**AND WHEREAS** Council complied with Section (2) of the *Drainage Act, R.S.O. 1990*, as amended.

**NOW THEREFORE** the Council of the Corporation of the Township of Augusta, pursuant to the *Drainage Act, R.S.O. 1990*, and amendments thereto, hereby enacts the updated assessment schedule attached to this By-law as well as the following:

1. The Municipality does hereby adopt the Drain Assessment submitted with this By-law and in pursuant to Section 65 (2) of the *Drainage Act* will update said assessment schedule if lands become subdivided or there is a change in property ownership from time to time.
2. That the provisions of the By-law shall come into force and take effect upon the passing thereof.

Read a first, second, and third time and finally passed this 11day of March, 2013.
