



**THE CORPORATION OF THE TOWNSHIP OF AUGUSTA  
BY-LAW NUMBER 3714-2024**

**BEING A BY-LAW TO RESTRICT THE RATE OF SPEED FOR MOTOR VEHICLES  
ON A ROAD PORTION WITHIN THE MUNICIPALITY**

**WHEREAS** Section 27(1) of the municipal Act S.O. 2001 as amended authorizes municipalities to pass by-law in respect of a road under its jurisdiction.

**WHEREAS** the Highway Traffic Act, R.S.O. 1990, Chapter H.8 Section 128(2) as amended authorizes the Municipal Council of a Township to prescribe a lower rate of speed for motor vehicles on a road or a portion of road under its jurisdiction;

**AND WHEREAS** it is deemed expedient by Council to restrict the speed of motor vehicles on certain roads in the Corporation of the Township of Augusta;

**NOW THEREFORE** the Council of the Corporation of the Township of Augusta enacts as follows:

1. When any road or portion of road set out below is marked in compliance with the regulations under the Highway Traffic Act, the maximum rate of speed thereon shall be 70 kilometres per hour for motorized vehicles:

2. When any road or portion of road set out below is marked in compliance with the regulations under the Highway Traffic Act, the maximum rate of speed thereon shall be 60 kilometres per hour for motorized vehicles:

3. When any road or portion of road set out below is marked in compliance with the regulations under the Highway Traffic Act, the maximum rate of speed thereon shall be 50 kilometres per hour for motorized vehicles:

4. When any road or portion of road set out below is marked in compliance with the regulations under the Highway Traffic Act, the maximum rate of speed thereon shall be 40 kilometres per hour for motorized vehicles:

Algonquin Road	Charleville Road	1.1 km West of Charleville Road

5. The penalties provided in subsection 128(14) of the Highway Traffic Act shall apply to offences against this By-Law.
6. That this By-Law shall be effective from the date and time of the posting of the prescribed signs pursuant to Regulation 615 under The Highway Traffic Act, R.S.O. 1990, Chapter H.8 as amended.
