ZONING BY-LAW 2965, AS AMENDED (Schedule D1)
7025 County Road 18; Con. 6, Pt. Lot 5, Pt. 1, 15R-12059
(Schedule D1 - Roebuck)**

YOU HAVE BEEN CIRCULATED THIS NOTICE as you are a prescribed person or public body to be circulated under O.Reg 545/06, of this proposed amendment (and provided mailed notice as per the Township's practice of providing added public notice). Formal Notice of the Public Meeting will be given by publication in the Brockville Recorder and Times Newspaper (on April 26, 2025). Attached is a Location Map of the subject lands.

TAKE NOTICE that a complete application to amend the Zoning By-law has been received in relation to the above-noted lands and the Council of the Corporation of the Township of Augusta will hold a Public Meeting on **Monday, May 26, 2025 at 6:00 p.m.** at the Township Municipal building located at 3560 County Road 26, in Maynard, Ontario to consider the following proposed Zoning By-law Amendment under Section 34 of the *Planning Act*, R.S.O., 1990:

7025 County Road 18 (Roebuck); Assessment Roll No. 0706 000 020 10900

The subject property is currently a 0.11 ha (0.27 ac.) lot with 36.6 m (120 ft.) road frontage, municipally addressed as 7025 County Road 18, Roebuck. The property was the location of a former church, where the church building is proposed/currently being used as a residential dwelling.

The purpose of this Zoning By-Law Amendment application is to rezone the lands from Institutional (I) Zone to Residential Village Exception Eight (RV-X8) Zone. The effect of the RV-X8 zone is to permit single-dwelling residential use and other possible specific RV uses such as: bed and breakfast establishment; day nursery – private; garden suite; group home; home occupation; park; parking area; public service use; public utility; secondary suite; and accessory uses to the foregoing.

The lands are designated Settlement Area in the Official Plan.

ANY PERSON may attend the Public Meeting and/or make written or verbal representation either in support of, or in opposition to the proposed amendments. If you wish to attend virtually, please contact the Clerk, by phone or email, as noted below to arrange such attendance. If you wish to provide written comments, but are unable to attend the meeting, please ensure that your written comments are received by noon on May 26, 2025, so your comments can be relayed to Council at the Public Meeting.

IF a specified person or public body as defined under the *Planning Act* or the registered owner of any land to which the By-law would apply would otherwise have an ability to appeal the decision of the Council of the Township of Augusta to the Ontario Land Tribunal (OLT), but the specified person or public body as defined under the *Planning Act* or the registered owner of any land to which the By-law would apply does not make oral submissions at a public meeting or make written submissions to the Township of Augusta before the proposed Zoning By-law Amendment is passed, the specified person or public body as defined under the *Planning Act* or the registered owner of any land to which the plan would apply is not entitled to appeal the decision to pass the proposed By-law.

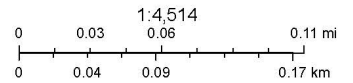


LOCATION MAP – 7025 COUNTY ROAD 18
